

WELLS BLUE SCHOOL P.T.A. '100 CLUB'

OBJECTIVES

- To raise finance for The Blue School PTA funds
- These funds will be used for normal PTA purposes, i.e. To purchase items which will contribute to the general quality of pupils' education.
- They will not be used to supplement the school's general budget or to purchase items normally provided by the LEA or other authority.

MEMBERSHIP

1. Membership is open to any person regardless of direct connection with the school.
2. The minimum age for shareholders will be 16 years of age.
3. The objective is that a minimum of 100 shares will be sold each month, to be entered in a quarterly draw.
4. Individuals will be issued with a fixed membership number which will be included in each quarter's draw provided the payment conditions have been met.
6. There will be a qualifying period of 3 months (or £3) for a number to be entered in the draw for that quarter.
7. A shareholder whose payment has not been received will not be eligible for inclusion in the draw for that quarter. In addition all arrears must be cleared from all quarters before the number can be included in any future draw.
8. Any disputes regarding membership or eligibility will be decided by the '100 Club' Sub Committee of the P.T.A., whose decision is final.

PAYMENT OF SHARE COST

1. Payments should be made **ANNUALLY IN ADVANCE**, by Cash or Cheque (made payable to 'The Blue School PTA 100 Club'). These should be sent to the School Office in sealed envelopes marked PTA '100 Club'.

DRAW AND PRIZES

1. A prize draw will be held at quarterly intervals, ideally at a School or social function. If no function is planned for the time of a draw it will be carried out at the nearest PTA meeting.
2. The prizes will, if feasible, be presented at the time of the draw. If winners are not present, prizes will be posted to their home addresses.
3. The prizes **PER QUARTER** will be in the following ratio, based on 50% of the share income for that quarter:

1 st prize	67%
2 nd prize	20%
3 rd prize	13%
4. The prize winners and amounts of prizes will be included in the school newsletter after each draw.
